



Real Matters Reports Third Quarter Financial Results

July 30, 2026

TORONTO, July 30, 2026 (GLOBE NEWSWIRE) -- Real Matters Inc. (TSX: REAL) ("Real Matters" or the "Company"), a leading network management services platform for the mortgage and insurance industries, today announced its financial results for the third quarter ended June 30, 2026.

"We delivered 13% year-over-year consolidated revenue growth and positive consolidated Adjusted EBITDA^(A) of \$0.7 million, which more than doubled, reflecting the operating leverage in our model. Our third quarter results demonstrated the strength and resilience of our business," said Real Matters Chief Executive Officer Brian Lang. "We continued to build momentum across our businesses in the third quarter, supported by 10 new client launches, market share gains and disciplined execution."

"Our U.S. Title sales pipeline remains strong, with new clients being onboarded every quarter. We are now live with three Tier 1 lenders, one of the largest U.S. mortgage servicers and holders of mortgage servicing rights, and one of the leading U.S. digital financial services platforms. U.S. Title origination volumes increased 170% year over year on a year-to-date basis, driven primarily by new clients. As volumes scale from these new client wins and market share gains across all segments, we believe Real Matters is well positioned to capitalize on the operating leverage in our model and deliver increasing value for our clients and shareholders. We are also continuing to invest in our platform, AI capabilities and capacity to support future growth, while maintaining a strong financial position with \$40 million in cash and no debt," added Lang.
